They will select participants on the basis of five (5) 4x6 photos of their work and one (1) 4x6 photo of the booth display (preferably at a show.) Poor photos may result in your not being accepted, so do your best photography work. Slides and CD's cannot be accepted. Please do not send your original artwork. Artists **MUST** be present to sell their work; no agents or representatives.

I hereby agree to the following terms and conditions, and those outlined on the "2010 Information Sheet for Artists". I understand that if I fail to comply with the Festival guidelines, the "2010 Information Sheet for Artists" and the conditions listed below, I will be ineligible to participate in subsequent Festival events.

1. I agree to be present **both** days of the Festival and open my display booth from 10 am to 6 pm, August 14-15, 2010.
2. I will have a minimum of 10 complete pieces of recent, original, and one-of-a-kind work prominently displayed at the Festival.
3. I will abide by restrictions on commercial reproductions: less prominent placement, clear and accurate labeling identifying the work as a "reproduction."
4. I will not have for sale non-art items, work by other artists, or souvenirs, including promotional T-shirts, magnets, food or beverages, etc.
5. I understand that over night security will be provided; however, I assume ultimate responsibility for my property.
6. I will work cooperatively with the event staff to ensure my belongings are off the field by 9:00 pm, August 15, 2010.
7. There will be no refunds of the Booth fee after being accepted.
